**Invitation for Bids for procurement of Fabricated Steel Parts
for Trail Bridges**

1. **Garuda Municipality Executive Office of the Municipality, Garuda,Rautahat** invites sealed bids from registered fabricators for supply of fabricated steel parts for following Trail Bridges. Detailed Evaluation and Qualification Criteria are provided in Section III of the Bid Documents.
2. Fabricator's with experience of successfully completing fabrication and supply of steel parts for minimum **Five trail bridges within last five years** are eligible for the bidding. New fabricators may also apply in joint venture with an eligible fabricator having the required experience. However, bids of such fabricators shall be considered responsive only in case fabricators fulfill the minimum requirements.
3. Eligible Fabricator may obtain further information and inspect the bidding documents at **Garuda Municipality, Executive Office of the Municipality, Garuda, Rautahat**.
4. Bidding documents may be purchased from the **Garuda Municipality, Executive Office of the Municipality, Garuda, Rautahat** by eligible Fabricator, on submission of a written application and upon payment of a non-refundable fee for bid documents as mentioned in the following table, until the (last date of purchase of bidding document) **2077/12/20 B.S (02/04/2021 A.D)** from the first date of publication of this notice.
5. Bids must be submitted to the **Garuda Municipality, Executive Office of the Municipality, Garuda, Rautahat** on or before **12:00 Hrs. noon on 2077/12/22 BS (04/04/2021 AD)**. Documents received after this deadline shall not be accepted.
6. Bids will be opened in the presence of Fabricator's representatives who choose to attend at Office of the Garuda Municipality on **2077/12/22 BS** at 14:00 Hrs. **(04/04/2021 AD)**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by bid security, amounting to a **minimum of 2.5 % of the quoted Bid amount (inclusive of VAT) as stated in the table below** which shall be **valid for 30 days** beyond the bid validity period.
7. If bidder wishes to submit the Bid Security in the form of cash, bidder has to deposit cash in Deposit Account No. **OICA052591852403 (NIC ASIA, Garuda Branch)** and submit bank deposit voucher along with the bid.
8. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered as the last day.
9. Pre-Bid Meeting shall be held at the office of the **Garuda Municipality, Garuda , Rautahat** at **11:00 Hrs.on 2077/12/06 BS (19/03/2021AD)**
